The candidate for this position will be responsible for leading a team of business and technical project and program managers responsible for driving the development, integration, test and introduction of new and legacy products meeting scope, schedule, budget and quality targets. There will be a high level of interaction with the Student Systems, Desktop Support, Database, and Applications teams and also cross-functional structures like the Digital District Steering Committee, Digital District Working Group, Data Governance Steering Committee. The position is also responsible for the development, implementation and governance of SFUSD's Project Management and Product Development methodologies and the organization's adoption of Agile and user-centered approaches project planning and implementation.

Demonstrate a Leadership Mindset

- Establish a vision and strategies for the Project Management Office to help SFUSD deliver on the Digital District Plan, Vision 2025, and *Transform Learning. Transform Lives.*
- Develop and deliver executive presentations on status, metrics, and feature roadmap for the Department of Technology and the Digital District Steering Committee, and Digital District Alliance Working Group
- Develop, implement, and govern PMO processes, tools, templates, policies and metrics, and disseminates them within and across SFUSD Departments
- Define best practices, innovate on processes, and evangelize across the team, Department of Technology, and SFUSD

Manage to Results

- Monitor and enhances departmental and cross-functional project plans to ensure goals are clear, measurable, and connected to the PMO vision; holds department accountable for meeting these goals
- Make recommendations for the allocation of Department of Technology and Digital District budget resources to achieve timely, high-quality outcomes.



- Facilitate the cross-functional Digital District Alliance Working Group and Digital District Steering Committee to share and evaluate ongoing progress toward goals
- Guides and advise the Chief Technology Officer and Executive Directors in making decisions related to divisional policies and resources
- Anticipate bottlenecks, provide escalation management, anticipate and make tradeoffs, and help balance the business needs versus technical constraints

Manage Teams

- Delegate tasks and projects to PMO office members; **directs** team members to the tools and resources needed to meet individual goals
- Create professional development opportunities for PMO direct reports and others in Department of Technology
- Review work of PMO and provides ongoing timely, relevant, and constructive feedback to team members, providing general coaching and supervision
- Identify and eliminate blockers and obstacles to progress and delivery on cross-functional projects
- Assist in building departmental camaraderie through presentations at All-Team Meetings and Leadership Team meetings.
- Direct a team of program/project managers to deliver cross functional programs focused on the delivery of SFUSD's product portfolio which includes software, hardware and cloud services that meets and exceeds scope, schedule, budget and quality expectations
- Assess team bench strength, skill set and capacity in order to adjust resource plans as needed
- Actively manage and coach direct reports to drive optimal performance

Manage Relationships

- Partners frequently with Chief Technology Officer, Executive Directors, and SFUSD leadership to expand on efficiency and impact of Digital District Steering Committee and Technology Governance
- Maintain working relationships with Department of Technology, Digital District Steering Committee members, and external partners to collaborate on high-level direction of cross-departmental and District-wide projects; represents Department of Technology during such interactions
- Drive effective teamwork, communication, collaboration and commitment across multiple disparate groups with competing priorities
- Communicate with internal teams, stakeholders and partners on a regular basis. Ensure all parties have accurate and current information

- Five (5) to seven (7) years of experience in project development or leadership with increasing responsibilities
