As the leader in the development of innovative technologies that support teaching, learning, student life and administrative operations, the Director will possess in-depth technical expertise and with the support of the Chief Operating Officer, will provide strategic leadership, planning, and management to all areas of information technology. The Director will develop and oversee campus-wide technology policies, procedures, services and facilities. The Director will work collaboratively with academic leadership to develop effective strategies for integrating technology into the curriculum. Qualified candidates will have a passion for technology and education, and proven leadership, management, and decision making skills. The successful candidate will be a hands-on manager and will have the ability to develop and lead strategic and operational initiatives; will have proven supervisory and staff development skills; and will possess exceptional communication and customer service skills. College degree in related field and a minimum of 5 years of technology management experience required. Experience in an educational setting, as well as experience with Blackbaud K-12 preferred.

- Work with the academic leadership to develop ways and strategies to effectively integrate technology into the curriculum.
- Establish and enforce information technology standards, procedures, and policies.

- Establish school infrastructure to support and guide divisions and departments in computing and information technology efforts.
