The position is a highly interactive and collaborative one that requires teaching experience, technical knowledge (focused on the end-user), managerial skills, and a passion for learning. A general understanding of the network infrastructure and a vision for the direction of educational technology are necessary for success in this position.

Major Duties and Responsibilities:

As the Director of Instructional Technology, the educator in this position:

- Provides direct support teaching and guidance to faculty and students in the use of instructional hardware and software
- Manages and develops the "Mice" program a student IT workforce
- Maintains and manages the Online School for Girls classes
- Works as an integral member of a small IT team
- Offers a course for students in technology
- Manages and implements *Hour of Code* workshops



- Creates and maintains online and printed help sheets and video tutorials for a variety of software and hardware (communication tools may include Faculty Resources, Google Drive, Google + Community)
- Assists administration and educators in planning for the use and integration of technology in the instructional program
- Works with faculty to facilitate and enhance the vision and goals of technology implementation; develops benchmarks for student technology proficiency
- Participates in the design, coordination, and provision of instructional technology training and workshops, including summer workshops
- Participates in technology-related professional development opportunities including self-study, workshops, and conferences on school, district, state, and national levels; participates in ACIS and ETC Technology Groups
- Maintains awareness of new technologies and makes future project and system suggestions
- Other duties as assigned
