This is a critical school role overseeing Atlanta International School's short-term operational efficiency and long term strategic planning, in order to ensure that the school's technology program is driven by and best maximizes student learning.

## **Essential Duties and Responsibilities**

#### **Technology Planning and Management**

- Works with school leadership and other stakeholders to develop and manage a Technology Strategic Plan as part of the overall AIS Strategic Plan
- Leads and facilitates collaborative conversations throughout the school focused on technology and innovation.
- Maintains an organizational structure that enables AIS academic and operational technology staff to achieve short-term and long-term goals
- Coaches and appraises both instructional and operational technology staff in routine operations and on their annual goals related to strategic initiative implementation
- Leads the annual budget and long-range financial planning process for AIS Technology through partnership with departmental stakeholders
- Responsible for maintaining budgets and tracking spending
- Performs benchmarking (both qualitative and quantitative) of AIS technology against local and international peer groups, and develop and implement performance metrics for all aspects of AIS technologies
- Actively manages risks, investments, and vendor relationships for school-wide technologies
- Ensures that process documentation exists for all routine operational procedures

#### 3K-12 Curriculum

- Leads school in aligning with the International Society for Technology in Education standards (ISTE)
- Works closely with the Head of Curriculum and Professional Development and the school's Academic Council to support and advance whole-school curricular and academic goals
- Helps to develop curriculum scope and sequence for ICT curriculum and integration into core subjects
- Identifies best practices and research to assist teachers in supporting student learning throughout the curriculum
- Is knowledgeable about all aspects of the curriculum with expertise in integration of IT in promoting effective teaching strategies, differentiation of instruction, and effective assessment techniques that can be used across languages and grades
- Coordinates and develops professional development opportunities for teachers and administrative staff, including planning and delivering workshops and developing resources
- Leads parent workshops on technology-related topics, including digital citizenship and Internet safety, technology and ICT curriculum overviews, use of the school website, school databases, and other online systems, and other topics as appropriate
- Explores and oversees opportunities for students to extend themselves through additional cocurricular and extra-curricular opportunities in technology
- Works with Librarians and Counselors to coordinate inter-departmental technology initiatives (i.e., Digital Citizenship, Information Literacy, etc.)
- Evaluates emerging advancements in technology and the latest research in ICT teaching and recommends changes to curriculum and infrastructure when appropriate
- Collaborates with faculty and administrative staff to develop technology-related policies (Responsible Use Policy, Social Media, etc.)

#### **Other**

- Maintains an active role in the local, national, and international educational technology community, attends and presents at conferences and workshops, and collaborates with other technology professionals to advance and promote the school's instructional technology program and ensure that the school maintains an innovative and effective approach to instructional technology
- Follows and implements all school policies and procedures as outlined in the Employee Handbook
- Oversee all IT-related recruiting
